The event will be at Natural Beauty Growers, N781 Curran Road, Denmark, WI 54208. This will be our 37<sup>th</sup> Fall Conference in our 69-year history of providing continuing education to Wisconsin greenhouse growers, managers, garden centers, horticultural educators, and students.

We will have three outstanding speakers at this year's event. Vaughn Fletcher of Fletcher Consulting in Liberty, MO will be starting us off with his top picks for 2023 annuals from his travels to tradeshow and trial gardens. Brent Horvath of Intrinsic Perennial Gardens in Hebron, IL will be presenting top perennials from Intrinsic Perennials. We will wrap up the day with Dr. J.C. Chong from Clemson University. J.C. will be teaching us the elements of identification and management of greenhouse pests.

The attendance at our 2021 Fall Conference held at Boerner Botanical Gardens hosted 100 participants. The event was also recorded and is available for members on our website. We are pleased to have Natural Beauty Growers host the event since our last event here in 2019. They will be assisting us in set up, preparing the noon meal, and providing tours during the lunch period.

Each booth will be a 10' x 10' space with a table and two chairs. They will be in the large hall between the meeting room and the morning coffee break and lunch area. We have three times designated for trade show contact during the program. All booths remain at the \$125 rate of past years. Additional booths can be rented at \$100. Trade booth registration includes pays for the attendance of two people in the booth. Each additional person will be charged \$10 per person.
